Solid slabs can be collected for disposal or re-use. If dust is generated during the fabrication process, use a high efficiency particulate air (HEPA) filter vacuum system or dampen the dusts, and sweep wet material for disposal. Do not sweep dry material.

Eye	Mechanical irritant. Due to product form and nature of use, the potential for exposure is reduced. Product may only present a hazard if material is cut, drilled or sanded with dust generation, which may result in mechanical irritation.
Sensitisation	Not classified as causing skin or respiratory sensitisation.
Mutagenicity	Not classified as a mutagen.
